4. [14267](#) 232 East Olin Avenue - Street Graphics Size Variance from a Provision of UDD No. 1 for "Coliseum Bar and Banquet." 14th Ald. Dist.

The motion required that the applicant return with a site plan that provides for identification and location of existing and proposed signs, details on both the existing and proposed signage for reference, in addition to providing a version of the sign which complies to the 40 square feet for comparison, and also provide views from John Nolen Drive in and outward bound, as well as other views of the site.

Provide vertical plantings on the exterior wall of the parapet and further defining of the path to the cabin area across the parking lot. It was further noted to find a way to give the building an exhibit context in relationship to the corner, including signage and other graphic design materials that provide context including previously approved details of the original approval of the Children's Museum.
